April 2025

- April: Oregon Health Policy Board approves membership slate

- April 30: Connecticut's target date for publishing its annual alternative payment model adoption report

May 2025

- May 1: Final date for Connecticut to identify payer and provider entities that exceeded
 the cost growth benchmark and/or failed to meet the primary care spending target and
 any other entities that significantly contributed to the state exceeding the benchmark.
 Connecticut then has to send official notice to each entity within 30 days.
- May 1: Washington publishes framework for cost driver analyses, with workplan and timeline for executing on the analytic agenda, including:
 - Recommendations for how to structure cost driver analyses
 - Recommendations for improving the current attribution methodology, and the time and resource intensity required to engage stakeholders in the redesign
- First week of May: Delaware publishes benchmark report

- May 12: Rhode Island Cost Trends Public Forum, and publication of Annual Cost Growth Target Report and Chartbook (collection of cost driver analyses using state APCD data)
- Oregon Affordability Committee launches
- Oregon reviews rules and sub-regulatory guidance on performance improvement plans (PIPs)
- Late May: Oregon releases benchmark report

June 2025

- June 7-10: AcademyHealth Annual Research Meeting
- June 10: Oregon hold public forum for benchmark report
- Mid-June: Connecticut to release cost growth benchmark specifications for 2023-2024 data request.
- June 23: Connecticut to hold public hearing on the 2023 benchmark results and new benchmark values for 2026-2030
